With appended copy letter to Mrs John Dick, Carstairhouse, near Lanark, informing her of the death of her sister Sophia. Dated at Fullarton Street, Irvine, January 1840

AA/DC35/1/1/1/3	1801 - 1807	Indenture of Apprenticeship between Hugh Cowan, manager of the Ayr Ropework Company and James Izatt, of Ayr and Thomas Izatt, father of James. Dated at Ayr, 15 September 1801. Endorsed with memorandum of expiry, dated at Ayr, 15 September 1807

AA/DC35/1/1/1/5	1812	Deed of feu by James Muir and James Izatt, rope spinner and sail maker in Ayr, for land in Wallacetown, Ayr, to raise dykes and build a dwelling house. Dated at Ayr, 29 January 1812
AA/DC35/1/1/1/6	1815	Agreement between James Izatt and James McKenna concerning the height of a demarcation wall between their feus in Wallacetown, Ayr. Dated at Ayr, 16 December 1815 (See also AA/DC35/1/1/1/5)
AA/DC35/1/1/1/7	c 1812	Specifications for a house to be built at the head of Fullarton Street by James Izatt and Hugh Dunlop
